We accept most of our immigration instructions on fixed fees. These fees are provided in accordance with the Solicitors Regulation Authority (SRA) Transparency Rules made by the SRA Board on 30 May 2018.

Our fees will include the following work:-

- a. Advising on the specific documents required for the application or appeal
- b. Ensuring that the documents are in accordance with the Immigration Rules
- c. Preparing the Application and/or witness statements and trial bundles
- d. Submitting the application and obtaining an appointment for your biometrics on your behalf
- e. Where necessary, submitting the trial bundle to the Tribunal/Court
- f. Briefing Counsel.

Human Rights Application	£1,500.00 - £2,500.00 plus VAT depending on the complexity of your matter. If there are unusual and complex features in your case, then the fees are likely to exceed.
Appeals to the First Tier Tribunal	
Lodgement of Appeal at the FTT on your behalf	£ 600.00 Please note that the fees will increase should we require to instruct Counsel due to the complexity of your case. We will provide you with written costs accordingly.
Preparing your case for trial by taking witness statements from yourself and witnesses, liaising with 3 rd parties to obtain evidence, preparing the trial bundle	£ 1,500.00 - £3,000.00 Please note that if your case is complicated then the fees would be more likely to increase. We will provide you with written costs accordingly.
Counsel Fees to attend Court	These fees vary depending on the Counsel and venue where the case is heard, however, you could expect to pay in the region of £900.00 – £1,200.00 + VAT.

Skeleton Argument will be between £600.00 - £900.00 depending on the complexity of the case.

If you require the presence of our solicitor at the FTT then the daily fee is £750.00 + VAT (£900.00)

Please note that the fees do not include disbursements, such as [Home Office Fees](#), [Immigration Health Surcharge](#) (both subject to change by the Home Office), costs for obtaining medical evidence, interpretation fees or expert report. Depending on the nature of your case these disbursements will be discussed from the outset of your case.

Please note that interpretation fees will vary depending on the language however a typical translation of for example a marriage certificate is about £90 - £120.

Our Hourly Rates

There may be exceptional cases where we may not be able to agree a fixed fee for your work. As it is not always possible to accurately know in advance what work is going to be involved, we will provide you with the best information possible about the likely cost at the beginning of the matter and at intervals while the matter proceeds. Hourly rates will only be charged in exceptional circumstances for complex matters where a fixed fee cannot be provided
